**SY 2011-2012 PARKING PATRON AGREEMENT**

The PRESBYTERIAN UNIVERSITY CENTER OF TALLAHASSEE, INC. (PUC), owner of a parking lot located at 548 West Park Avenue, Tallahassee, Florida, offers parking privileges for one (1) vehicle owned by:

(herein known as Patron) for an annual fee of Eight Hundred Twenty Dollars (\$820.00) and 7.5% Florida Sales Tax in the amount of Sixty-One and 50/100 Dollars (\$61.50) for a total of Eight Hundred Eighty-One and 50/100 (\$881.50) Dollars, made payable by check or cash to the Presbyterian University Center at this address.

This agreement is subject to the following:

1. Term is August 22, 2011 through August 21, 2012
2. Parking is offered on a first-come/first-serve basis, twenty-four hours per day, seven days per week (24/7). Patronage does not guarantee space availability.
3. Others authorized by PUC's University Minister or its Board of Directors may park in the lot at any time.
4. Patronage applies to this vehicle only:

5. Patron agrees to notify PUC promptly of changes of name, address, or vehicle type, tag, or other identification information.
6. PUC issues vehicle ticket/decal for authorized vehicles upon payment. Ticket/decal must be current and visible from outside the vehicle. Affix ticket/decal inside the lower left corner of the vehicle's front windshield, driver's side.
7. Patrons enter, park, and exit voluntarily and at their own risk. PUC is not liable for persons or their possessions, vehicles, or vehicle contents at any time.

8. Patron releases PUC, its Board of Directors, agents, and employees from liability arising out of parking lot use and occupancy including, but not limited to personal injury and/or loss, theft or damage, whether to patron her/himself, her/his motor vehicle, possessions or property, or to patron's family member(s) or guests.
9. Patron absolves, exempts and releases PUC, its Board of Directors, agents, and employees from any and all expenses including, but not limited to court and attorney's fees or other costs that may occur as a result of any litigation or claims.
10. Patron acknowledges receipt of a parking ticket/decal and agrees to display it as directed in 6., above, when parking at PUC.
11. Patron agrees not to occupy spaces where signs read "PUC Residents" or "PUC Residents and/or Staff" or "Reserved for Circle K" or any other spaces marked or posted as restricted otherwise at any time. Unauthorized vehicles parked in these spaces may be towed at vehicle owner's expense.
12. PUC may terminate this agreement prior to August 21, 2012. In such event, PUC will provide patron written notice of such impending termination at least thirty (30) days in advance and will refund patron the appropriate *pro rata* portion of any fees paid.
